#### **Decision**

When a request for information is made under FoIA 2000, a public authority has a general duty under section 1(1) of the Act to inform an applicant whether the requested information is held. There is then a general obligation to communicate that information to the applicant.

In line with section 1(1) of the FoIA, I can confirm the College **holds some information** relevant to your request. For ease, we have dealt with each part of your request separately:

The data provided above is based on the whole of the College of Policing's Selction & Assessment (S&A) team. S&A is comprised of staff in psychologist roles at various grades and non-psychologist staff who manage delivery and logistics of assessment processes. The data provided above is from the College's HR department and is not broken down by grades or roles.

Below, please find a numerical breakdown of those staff who are specifically involved in design of assessments or centre managers. We do not hold data on diversity characteristics in relation to these members of staff, only generically for the whole of S&A, as provided above.

#### Psychologists:

- 11 members of staff who are Registered Psychologists, i.e. hold the title of Chartered Psychologist (CPsychol)
- 10 members of staff who are currently enrolled on the Qualification in Occupational Psychology
- 6 members of staff who will enrol on the Qualification in Occupational Psychology in 2022.

#### Other:

1 member of staff.

However, please note that the job titles of Psychologist and Higher Psychologist used by the College do not correlate to registered psychologist status.
